POSITION OVERVIEW:

The United States District Court for the Northern District of Iowa is seeking applications for the position of Elbow Law Clerk to District Court Judge Linda R. Reade. The successful applicant must be able to start work August 1, 2017.

The position is located in Cedar Rapids, Iowa. Cedar Rapids is a medium-sized community located in eastern Iowa.

The successful applicant will be a part of the Chief Judge's staff, which consists of a Judicial Assistant, two Elbow Law Clerks and a Legal Advisor.

Applicants must be willing to commit to at least one year of employment with the court; however, employment shall be conditioned upon satisfactory job performance.

The successful applicant will have the opportunity to research a variety of legal issues, draft memoranda, draft jury instructions and draft opinions.

MINIMUM QUALIFICATIONS:

A degree from a law school of recognized standing in the upper one-quarter of the class (or certified completion of all law school studies and requirements, and merely awaiting conferment of degree by August 2017) is required.

Applicant must possess excellent research and writing skills and be an organized, highly motivated team player.

Law Review experience, publication of a noteworthy article in a law school publication or other scholarly publication, moot court experience or prior legal employment is preferred.

ADDITIONAL INFORMATION:

The United States District Court requires employees to adhere to a code of conduct which is available upon request.

The Financial Reform Act requires direct deposit of federal wages for Court employees.

Due to the volume of applications, not all applicants will be interviewed. The Court will only communicate with those individuals who will be interviewed.
