Under the Criminal Justice Act, 18 U.S.C. § 3006A(a)(1) & (c), the Office of the Federal Public Defender for the Districts of Iowa (FPD) is hereby appointed to represent any defendant sentenced in this district, previously determined to have been entitled to appointment of counsel, or who is now indigent, to determine whether that defendant may qualify to seek reduction of sentence and to seek relief in accordance with 18 U.S.C. § 3582(c)(2) and the 2023 Criminal History Amendments to the Sentencing Guidelines, including Part A (Status Points under § 4A1.1) and Part B (Zero-Point Offenders), made retroactive by recent amendment (herein after the 821 Amendments).


The FPD may take any appropriate actions in the cases in which it is appointed, *except that* the court is sua sponte reviewing the cases for all defendants identified by the Director of the Office of Research and Data for the United States Sentencing Commission, on the lists (attached) entitled “Sentenced Individuals Estimated to be Eligible for Sentence Reduction Under Part A of Amendment 821 Limited to Individuals Estimated to be in Prison as of February 1, 2024 District of Northern Iowa” and “Sentenced Individuals Estimated to be Eligible for Sentence Reduction Under Part B of Amendment 821 Limited to Individuals Estimated to be in Prison as of February 1, 2024 District of Northern Iowa.” Regarding the defendants identified in those lists, the FPD need not file any motion or briefing unless directed to do so by the court in a separate order.

The United States Probation Office for the Northern District of Iowa and the United States Clerk's Office for the Northern District of Iowa may disclose Presentence Investigation Reports, Judgments in a Criminal Case, including sealed Judgments, Statements of Reasons, Motions for Departure based on Substantial Assistance, and other documents available on the court's docket or are necessary for the FPD to determine whether particular defendants are eligible for a sentence reduction under the 821 Amendments, and to determine whether a conflict exists that would preclude the FPD from representing a defendant.

Should the FPD determine that a prohibitive conflict exists in which the prospective client's interests are materially adverse to those of a current or former client, or any other conflict exists that would preclude the FPD from representing a defendant otherwise eligible for representation under this order, the FPD shall file a sealed notice to the court stating that a conflict exists and the Clerk of Court shall appoint a member of the Criminal Justice Panel of this District to represent the affected defendant.

**IT IS SO ORDERED.**


