PUBLIC ADMINISTRATIVE ORDER

No. 23-AO-0003-P (Supersedes No. 07-AO-0013-P)

The maximum per page original transcript fee rates and maximum per page copy transcript fee rates are set by the Judicial Conference of the United States Courts. At its September 2022 session, the Judicial Conference approved an increase to the maximum per page transcript fee rates (see attached chart). As outlined in a memorandum dated November 15, 2022, the Director of the Administrative Office of the United States Courts directs each federal court to adopt a schedule of per page transcript fees, which are subject to the maximum rates established by the Judicial Conference.

The court hereby adopts the maximum per page transcript fee rates as set forth in the attached chart. Such rates apply to all transcript orders received on or after October 1, 2023, which is the date that signifies the beginning of fiscal year 2024 for the United States Courts. All transcript orders received prior to October 1, 2023, or prior to the beginning of the applicable fiscal year, must be billed at rates that do not exceed the rates that are set forth in the attached chart. The increased rates for fiscal year 2024 and fiscal year 2025 apply to publicly funded transcripts as well as privately funded transcripts.

This public administrative order supersedes Public Administrative Order No. 07-AO-0013-P, which is dated November 7, 2007. This public administrative order will take effect on October 1, 2023. The Clerk of Court is directed to place a copy of this public

administrative order in the public binder and post it on the court's website.
