

REDACTED NOTICES OF ELECTRONIC FILINGS (NEFs)

WHAT

The Northern District of Iowa allows parties to receive Notices of Electronic Filing (NEFs) in sealed cases. The clerk's office will no longer email the sealed documents to the counsel of record, requesting a return email of confirmation of receipt.

You will only be granted access to the document if you are an attorney on the case. If you are not granted access, you will not be able to open the document.

HOW TO ACCESS SEALED DOCUMENTS THROUGH THE REDACTED NEF

1. The attorney on the case will receive an e-mail containing the redacted NEF. There is no information as to what has been filed on this document.

This is an automatic e-mail message generated by the CM/ECF system. Please DO NOT RESPOND to this e-mail because the mail box is unattended.

*****NOTE TO PUBLIC ACCESS USERS***** Judicial Conference of the United States policy permits attorneys of record and parties in a case (including pro se litigants) to receive one free electronic copy of all documents filed electronically, if receipt is required by law or directed by the filer. PACER access fees apply to all other users. To avoid later charges, download a copy of each document during this first viewing. However, if the referenced document is a transcript, the free copy and 30 page limit do not apply.



4. If there is no hyperlink by the Document Number, there is no document attached to that entry. (i.e. Judges were added to the case, a docket annotation may have been made).

5. If there is a hyperlink next to the Case Number you will be prompted to log in to CM/ECF.
6. Clicking on the “here” hyperlink will take you to the unredacted NEF, which will then allow you to see the docket text of what has been filed.
