PUBLIC ADMINISTRATIVE ORDER

No. 23-AO-0002-P (Supersedes No. 16-AO-0008-P)

The court's Local Rules provide that "[c]ertain categories of documents, because of their nature, are sealed by the [Electronic Case Filing (ECF)] system without a motion by a party or an order of the court." Local Rule 5(c)(2). Documents that fall within such categories are referred to as "system-sealed" documents. See id.

The ECF system automatically seals documents that are listed on the court's website: www.iand.uscourts.gov.

Id. A party filing a document that is set forth in the court's List of Documents Automatically Sealed by the ECF System need not file a motion for leave to file the document under seal.

Id. Rather, such "party . . . must file the document under seal directly through the ECF system."

Id.

A "system-sealed" document is subject to being unsealed in any case as the progression of the case dictates or at the discretion of the presiding judge. Anyone seeking to unseal a "system-sealed" document in a case must file a motion that sets forth with particularity good cause justifying the unsealing of the document. A showing of good cause must include the reason for making public the specific information contained or believed to be contained in the document and a legal basis for unsealing the document. Additionally,

such motion must include a statement regarding the position of each non-moving party. See Local Rule 7(k).

This public administrative order supersedes Public Administrative Order No. 16-AO-0008-P, which is dated September 2, 2016. This public administrative order will take effect on July 24, 2023. The Clerk of Court is directed to place a copy of this public administrative order in the public binder and post it on the court's website.
