PARKING INSTRUCTIONS

601 - 2nd Street SE, Cedar Rapids, IA 52401

- Park on the ground level of the South Side Ramp located across the street from the Federal Courthouse (driving directions on reverse). **DO NOT PARK** in neighboring parking lots. Those are private lots and you may be ticketed. The court is not responsible for parking tickets or towed vehicles.
- Jurors park free of charge by entering the code following the directions provided below. Do not use an app or credit card to pay for parking.

2. To enter code, go to the pay station located in the south stairwell of the ramp:

- ❖ Press the green “OK” button to start
- ❖ Enter your license plate number - press “OK”
- ❖ Press “1” - Purchase Ticket
- ❖ Press “2” - Juror Parking
- ❖ Enter “10” hours - press “OK”
- ❖ Enter Code: _____ - press “OK”

TO PARKING RAMP (601 – 2nd Street SE, Cedar Rapids, IA 52401)

From the North: Driving south on I-380

- Take Exit 19B (1st Ave/Veterans Memorial/Kingston/Ice Arena) keeping left. Go straight at stoplight onto L Street SW.
- Turn left onto Diagonal Drive SW (this will turn into 8th Ave SE).
- Keep left and continue onto 8th Ave SE across the river.
- At the first stoplight across the river, turn left onto 2nd Street SE.
- The parking ramp entrance is down a block on the left.

From the South: Driving north on I-380

- Take Exit 19A keeping right. Turn right onto Diagonal Drive (this will turn into 8th Ave SE).
- Merge left and continue onto 8th Ave SE across the river.
- At the first stoplight across the river, turn left onto 2nd Street SE.
- The parking ramp entrance is down a block on the left.

From HWY 151:

- Follow Hwy151 South to Hwy 13. Turn left at Hwy 13 to continue on Hwy 151 South to Mt Vernon Road SE.
- Turn right onto Mt Vernon Road SE. Continue on Mt Vernon Road (this will turn into 8th Ave SE) to 2nd Street SE.
- Turn right on 2nd Street SE. The parking ramp entrance is down a block on the left.
